Dear Members of the New York Chapter of the Copyright Society:

We are excited to invite you to our **November 18th, 2009, luncheon program**, at noon, at the Princeton Club, 15 West 43rd Street, New York, NY.

“\$80,000 A SONG?”

A song download costs some 99 cents on iTunes. In contrast, in July of this year, Jammie Thomas was ordered to pay damages of \$80,000 per song, for each of the 24 songs she was found liable for infringing, for a total of \$1.92 million -- although the judge in her case had found the jury's previous \$222,000 award “oppressive.” Joel Tenenbaum was ordered to pay damages of \$22,500 for each of the 30 songs he was found to have infringed, for a total of \$675,000.

Are these per song statutory damages constitutional? Are they likely to be effective in deterring infringement? The EFF and others are questioning these awards, and the PRO-IP Act's per song statutory damages provision. Making available issues are also implicated, and we wonder about the upcoming role of the Copyright Czar . . .

SPEAKERS:

JENNIFER PARISER is Senior Vice President of Litigation and Legal Affairs for RIAA, where she oversees all litigation matters and provides counsel on a variety of other issues. She has more than two decades of legal experience and expertise in intellectual property law and most recently worked as Senior Vice President & Associate General

Counsel, Litigation and Anti-Piracy at Sony Music Entertainment. There she oversaw the company's response to all legal matters, including copyright, trademark and anti-piracy litigations. Prior to her tenure at Sony Music, Jennifer was an associate with Patterson, Belknap, Webb & Tyler and Debevoise & Plimpton in New York and also served as a judicial clerk to the Honorable Charles Tenney in the United States District Court for the Southern District of New York.

Ms. Pariser is a member of the Copyright Society of the USA (CSUSA) and has lectured extensively at the American Bar Association, N.Y. State Bar Association, PLI, CSUSA and various law schools. She holds a Bachelor of Science degree from the Georgetown University School of Foreign Service, and a Juris Doctor from the New York University School of Law.

RAY BECKERMAN is a veteran New York commercial litigator and internet law attorney with extensive experience in business law, copyright, trademark, entertainment, libel, slander, internet, computer software, business torts, and other areas, who has litigated hundreds of cases. He has authored two *amicus curiae* briefs on the issue of the unconstitutionality of the RIAA's statutory damages theory on due process grounds, and authored the winning brief on that issue in UMG v. Lindor, 2006 WL 3335048 (EDNY 2006). He began his legal career with Phillips, Nizer, Benjamin, Krim & Ballon, working his way through night law school, and upon graduation becoming an attorney in that firm. A member of the Copyright & Literary Property Law Committee of the Association of the Bar of the City of New York, and a past member of the Association's Entertainment Law, Information Technology Law, and Civil Court, committees, he has been widely published, and is the author of "Recording Industry vs. The People", a blog about digital online copyright law, focusing especially on the RIAA's litigation campaign against alleged end users of peer to peer file sharing software. He is a member of the Hall of Fame of Slashdot.org, where he is known as "NewYorkCountryLawyer", and is ranked by Twitalyzer as one of the 36th most "influential" user of Twitter. Scholarship / Financial Hardship Policy

A limited number of scholarships are available to judges, law clerks, law professors, law students, attorneys, pro bono attorneys and paralegals who work for nonprofit organizations, legal service organizations or government agencies, recent graduates not yet employed, and unemployed attorneys who must take CLE courses in order to meet their state requirements.

All requests must be made in writing accompanied by a completed registration form. No more than three requests per person will be considered in any one year. Requests should describe the applicant's interest in the topic and justification for a waiver of fees.

Requests should be accompanied by a recommendation from an instructor in the case of students, or supervisors in the case of law clerks or paralegals.

Requests and scholarships are not transferable. Approval will be based on need and funds available on a first come first served basis. If approved, the scholarship will result in a waiver of the course fees for the specific program application. To apply, please send your request, in writing, prior to the reservation form deadline. Students must submit a copy of their student identification cards.
